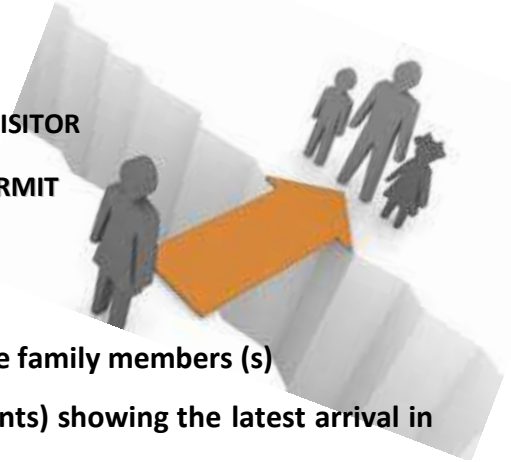


**FAMILY REUNIFICATION- SPOUCE/ CHILD VISITOR  
REGISTRATION AND FIRST RESIDENCE PERMIT  
REQUIRED DOCUMENTS**



- **Accompanying document for the type of application for the family members (s)**
- **Family members' passport copies (or other travel documents) showing the latest arrival in the Republic and visa**
- **Passport Copies of the sponsor and the family members (valid for at least 2 years from the date of application)**
- **Marriage Certificate. The couple must be married at least 1 year before submitting the application**
- **Birth Certificate of the Family Members:**

***Please note!***

**Spouse must be 21 years old**

**Children must be below the age of 18 and not married**

- **Certificate of School Enrolment/Attendance (if applicable)**
- **Court decision on the adopted minor children of the sponsor and of his/her spouse (if applicable)**
- **Court custody decision of minor children (if applicable)**
- **Original Criminal Record Verification for sponsor's family members. (Not necessary for children under the age of 16)**
- **Original medical examination results for sponsor's family members (AIDS, Hepatitis B and C, Syphilis and Tuberculosis- TB) from the country of origin**

***Please note!***

**Regarding TB: No X-Ray is required for children under 15 years old. The Mantoux Skin test is also accepted. The Mantoux test can be performed at, or validated by the Public Hospital's Pulmonary Clinics**

**For children under the age of 6 that were born in Cyprus, medical examination results are not requested.**

- **House/ apartment Title of ownership, or rental agreement, duly stamped, of the sponsor:**

*Receipt of rent, if applicable*

*House/ apartment description*

- **Health Insurance valid Health Certificate for medical care covering BOTH inpatient and outpatient care, as well as transportation of corpse, automatically renewable OR Registration Certificate in the General Healthcare System (GHS- GESY) and private Health Insurance for inpatient Health care and transportation of corpse**
- **Valid contract of employment of the sponsor duly signed and stamped for the min. duration of 18 months from the date of application (or of open duration)**
- **Sponsor's Income Tax Returns (for all years of residence in Cyprus)**
- **Sponsor's Certificate of contributions to the Social Insurance Fund (Form YKA B-9)**
- **Sponsor's VAT returns, for all years of residence in Cyprus (applicable only when sponsor is the only shareholder)**
- **Sponsor's Income Declaration (for income sources other than employment- if applicable- accompanied by affidavit)**
- **Sponsor's bank account statements**
- **Sponsor's Utility bills (i.e. phone, electricity or water)**
- **Original Declaration of honor to cover the cost of return of the 3<sup>rd</sup> country National**
- **Authorisation for payment by bank transfer (FIMAS)**
